## POLICY STATEMENT

### SELECTION OF APPROPRIATE TEXTS

Review: 2021

---

**RATIONALE:** Nagle Catholic College, as a Catholic school, aims to help students to integrate culture, faith and life. Culture is valued and Nagle Catholic College promotes discussion and critical thought. The values and attitudes at Nagle Catholic College are founded upon the teaching of Jesus Christ. Therefore, the selection of texts is a rigorous and careful process.

**PRINCIPLES:**

1. Texts are used to:
  - support and develop the desired outcomes of schooling
  - address student diversities in culture, gender, special learning needs and socio-economic background
  - provide students with learning experiences, which access a wide range of knowledge, understandings and skills.
2. Texts enable students to:
  - develop their unique potential – physical, emotional, creative, spiritual, intellectual, moral and social
  - develop a critical understanding of the diversity of beliefs and values found in society and in human experiences
  - deepen their understanding of the values of Christ including absolute values such as the sacredness of human life and the dignity of the human person.
3. Some texts enable students, with assistance, to challenge dominant societal ideas, particularly stereotypes and undesirable models of human behaviour.
4. Texts dealing with controversial topics or challenging situations need to be selected with sensitivity to community expectations.
5. Texts containing gratuitous or extreme violence or pornographic material have no place in a Catholic school.

**DEFINITIONS:**

1. The term 'text' refers to any form of written, spoken or visual communication involving language.
2. The term 'non-print texts' includes:

*advertising, artefacts, CD ROMs, documentaries, feature film, radio broadcasts, recorded music, short film and television programs.*

3. The term 'print texts' includes:  
*advertising, CD ROMs, comics, current affairs, cartoons, diaries, encyclopaedias, essays, feature articles, instruction manuals, journals, letters, magazines, newspapers, novels, novellas, picture books, photo essays, plays, poetry, posters, prayers, short stories, signs, song lyrics, sourcebooks, speeches, story boards, textbooks, transcripts, web pages and any printed fiction or non-fiction material.*

**PROCEDURES:**

1. Texts, which are made available to students at Nagle Catholic College, are all previewed and evaluated prior to their selection and use. In particular, recommended curriculum materials or syllabus texts will be extensively reviewed before inclusion in the library or used in classes.
  
2. The Principal and/or the Library Manager are the first persons to consult for advice on the selection of texts and the Office of Film and Literature Classification Guidelines for non-print texts. The document, *Guidelines for the Classification of Films* is available in the Library. It should be noted, however, that these guidelines must work within the framework of this document, which forms part of the ethos of a Catholic School.
  
3. In selecting a documentary, feature film, television program, animated film or short film, the guidelines set by the Office of Film and Literature Classification apply:

<b>G</b>	<b>GENERAL</b> – Suitable for all ages. Suitable for Years K-12
<b>PG</b>	<b>PARENTAL GUIDANCE</b> – Parental guidance recommended for persons under 15 years. Suitable for Years 8-12
<b>M</b>	<b>15 + and over MATURE</b> – Recommended for mature audiences 15 years and over. Suitable for Years 10-12
<b>MA 15+</b>	<b>MATURE ACCOMPANIED</b> – Restrictions apply to persons under the age of 15. The MA category is legally restricted. Children under 15 will not be allowed to see MA films or hire them on video unless in the company of a parent or adult guardian. Some may be suitable for Years 11 and 12.
<b>R 18+</b>	<b>RESTRICTED</b> – Restricted to adults 18 years and over. The R category is legally restricted to adults. Material, which is given a restricted classification, is unsuitable for those under 18 years of age. Material classified R deals with issues or contains depictions that require an adult perspective. Not suitable for high school students.
<b>X 18+</b>	<b>RESTRICTED</b> – Restricted to adults 18 years and over. Not suitable for high school students.

4. This set of guidelines is to be applied for any use of non-print texts.
  
5. Where the class teacher and the relevant Head of Learning Area consider the text suitable (e.g. a documentary on the Holocaust which contains graphic footage) but its rating is above the recommended age limit, then permission

must be sought from the parent or guardian by letter and reply slip. If a parent or guardian declines consent, then, where possible, the student will be provided with an alternative text covering similar concepts.

6. It is not the policy of Nagle Catholic College to abridge a text and no text will be censored by the removal of pages or editing of footage because this contravenes the Copyright Act.
7. If a parent or guardian makes a complaint about the relevance or suitability of a text, the following procedures should apply:
  - 7.1 Ascertain the nature of the complaint:
    - Content
    - Language
    - Concepts
    - Relevance
    - Religious / ideological concerns
  - 7.2 Refer the matter to the relevant Head of Learning Area.
  - 7.3 The teacher and/or the relevant Head of Learning Area shall meet the parent or guardian to discuss the complaint, where every attempt will be made to address their concerns.
8. Nagle Catholic College will remove a text from its lists if there are sufficient grounds for its removal. If appropriate, the relevant authorities at Catholic Education Western Australia (CEWA) and the School Curriculum and Standards Authority (SCSA) will be consulted, after the complaints have been examined. The Principal will have the final say as to the removal of a text. In the case of a text having a number of different complaints brought against it, each complaint will be examined independently.
9. If a member of the general community makes a complaint, the nature of the complaint should be ascertained. The matter should be reported to the Principal.
10. Nagle Catholic College has Internet safeguards to prevent students accessing materials that are of a dubious nature, inappropriate, offensive or irrelevant.
